



Enjoy the conference and the wonderful city of San Diego.





## A-2 An Integrated Responsible Retailing Model

**Executive Center III A** 

Alcohol control / enforcement agencies in four states have joined the Responsible Retailing (RR) Forum in piloting a model of RR drawn from an upcoming Federal guidance document, Report on Best Practices (BPs) for RR. The integrated RR model is based upon a Community Policing approach in which public and private stakeholders assist off-premise licensees to identify and implement BPs. In a quasi-experimental design, participating retailers in Birmingham, Des Moines, Santa Fe, and Springfield, Missouri, are using a new quality improvement tool and/or receive a series of mystery shopper reports.

Law enforcement is challenged by an overwhelming variety of demands and budget constraints. Why, then, are compliance checks important? Compliance check operations, once organized, are easy to do, increasingly less expensive, and if done regularly, result in greater retail compliance. ## A-9 California Alcoholic Beverage Control Department's TRACE Program

Marina II

The Target Responsibility for Alcohol Connected Emergencies (TRACE) program was developed to hold ABC licensees accountable for providing alcohol to minors who are later involved in serious incidents. Although California's ABC works closely with local law enforcement, the department normally did not receive notification of deaths or injuries involving minors until weeks, and sometimes months, after the event. By then, it was virtually

impossible to track the source of the alcohol. TRACE now allows emergency scene investigators to contact the ABC 24 hours a day. The workshop will detail the extraordinary chain of events that led several organizations to develop the TRACE protocol.

### A-10 Recent Findings on Underage Drinking and its Consequences from the National Evaluation of the Enforcing Underage Drinking Laws Program

Included in this survey data are findings on beer brand preference by underage drinkers, locations where underage youth consume alcohol, and relationships between underage drinking and violence and sexual victimization against adolescent girls. The Navy's underage (20 and younger) population represents a significant portion of the military organization, requiring many military prevention programs to target underage drinkers. DAPMA San Diego's Alcohol and Drug Abuse Prevention training has been in operation since October 1995, and the Navy Prevention Specialist training has been conducted since July 2003. This workshop builds on previously learned skills and knowledge, emphasizes the science of prevention applied to military programs, and demonstrates parallels between military and civilian alcohol abuse prevention programs. Military and civilian collaboration maximizes the benefits of existing prevention programs to reduce the negative impact of underage drinking on both communities.

## A-12 Parents Are Part of the College Solution: Parental Notification

Parental involvement kicks things up a notch. Federal law now allows colleges to inform parents when policy violations such as alcohol infractions have occurred. Partnering with parents in development and implementation of Parental Notification Policy significantly reduces repeat student alcohol offenses. Texans Standing Tall, in collaboration with Texas A&M University, Texas Alcoholic Beverage Commission, and Texas Sport Coalition engaged enforcement, administration, and policymakers in strategies to expand the impact of parental notification, which has already produced impressive results in this college setting.

#### **Keynote Speaker: J. Robert Flores**

J. Robert Flores was confirmed by the Senate and sworn into office as the Administrator, Office of Juvenile Justice and Delinquency Prevention (OJJDP), Office of Justice Programs (OJP), U.S. Department of Justice in 2002. He is responsible for the agency that Congress has mandated to address the public safety issues of juvenile crime and youth victimization. His

OJJDP leadership responsibilities include identifying effective strategies for addressing juvenile crime through research; coordinating, implementing, and supporting effective programs and encouraging innovative approaches to deal with existing and emerging juvenile justice issues; developing priorities and goals and setting policies to guide Federal juvenile justice issues; providing technical assistance and training to essential components of the juvenile justice system; disseminating information on juvenile justice trends, programs, and new approaches; and awarding funds to States to support local programming nationwide. Previously, Mr. Flores was an Assistant District Attorney in Manhattan where he successfully prosecuted numerous child sexual abuse cases. He earned his J.D. from the Boston University School of Law and his B.S. in business administration from the Boston University School of Management.

## B-1 GIS: An Environmental Public Policy Tool

Marina I

The University of Wisconsin-Madison is one of 10 college sites supported by a Robert Wood Johnson Foundation project-"A Matter of Degree Program"-designed to test environmental strategies to reduce high-risk drinking. Environmental strategies center on policy changes that are implemented through the work of community coalitions. This presentation will emphasize the use of GIS mapping as a tool to develop policy to address the easy accessibility of alcohol to youth.

## **B-2** Keg Registration In Washington State

**Executive Center I** 

The Washington State Liquor Control Board developed their keg registration laws in 1989 to confront alcohol consumption at teen parties. The low cost of keg beer makes the beverage especially attractive to price-sensitive youth. Participants will learn creative strategies and techniques to maximize the impact of well-developed keg registration legislation.

Canada and Mexico have lower drinking ages than the United States, which creates unique underage drinking behaviors and problems for border communities. This session will look at how the City of Brownsville's underage drinking initiative has reduced problems along the U.S./Mexican border. ### B-4 Control the Game, Know the Rules, and Call the Foul

The NIAAA and IOM reports highlighted the need for enforcement on college campuses. Research findings indicate freshman students commit the majority of alcohol violations in the residence system. A Statewide initiative committee in Texas developed a model training program for resident assistant (RAs). The panel will describe the RAs' training, which emphasizes knowing of rules (policy) and calling the fouls (enforcement). The workshop will define the role of the RA in identifying and enforcing underage alcohol violations in the residence system.

#### **B-5** When the State Fails to Act

Over the past 3 years, the Connecticut Coalition to Stop Underage Drinking has worked to modify State law concerning house parties where alcohol is provided to underage youth. It has not passed yet, so towns have passed local ordinances with similar provisions. The stance that these towns have taken is that they cannot wait for the legislature to act before they intervene to decrease the number of parties where alcohol is served to youth.

Through compliance testing, the Vermont Department of Liquor Control (DLC) tracks whether employees of on- and off-premise locations are meeting the statutory education requirements. Our statistics prove that employees trained by DLC investigators have a higher compliance rate than those trained by their employers only or those not trained at all. Participants will learn that education and enforcement do go hand in hand in reducing youth access to alcohol.

## Federal Efforts on Underage Drinking: Inquiring Minds Want to Know

What is going on in Congress? What are the Administration's priorities on underage drinking? The National Academies of Sciences report, the Federal Communications Commission's assessment of alcohol advertising, the Special Occupational Tax, the

Interagency Task Force on Underage Drinking, and regulating alcohol advertising in college sports are all important developments, and will influence the way we do our work and conduct business. This panel of policy experts will discuss current activity in Washington around these issues and explore cutting edge issues to be developed over the next several years.


#### C-8 Compliance Decoys vs. the Real McCoy

Minor decoys used to conduct compliance checks are not allowed to lie to the clerks when attempting to purchase alcohol. Therefore, to never fail a compliance check, a clerk only needs to ask a minor's age, then not sell to anyone admitting he or she is not 21. Retailers often note that law enforcement compliance checks are unrealistic, because minors actually trying to purchase alcohol illegally will lie, use fake IDs, or use someone else's identification. The "Real McCoy" operation conducts a more realistic compliance check that was suggested by the retailers themselves to determine "real life" compliance rates. Sgt. Aymami will present the operation procedure and the outcome of this enforcement activity in Douglas County, Nevada.

### The Role of ABCs in the Enforcement and Adjudication of Alcohol Policy

The enactment of the 21st Amendment to the U.S. Constitution in 1933 gave primary authority for regulating alcohol availability to the states. Since that time, different alcohol control systems have evolved in each state, district, and territory of the United States. Most states have created alcohol beverage control (ABC) agencies to exercise this authority, implementing state laws that regulate how alcoholic beverages are manufactured, packaged, distributed, sold and consumed.

This plenary will offer an overview of the role of state ABC agencies in the prevention of alcohol-related problems, focusing on the agencies' powers to: (1) license alcohol establishments; (2) enforce alcohol laws and regulations; and (3) adjudicate violations of these policies. Agency representatives will address how these powers are implemented, and the challenges faced by ABC agencies, including the coordination of efforts between state and local enforcement agencies. A representative from a statewide network of community coalitions will discuss strategies for cooperative efforts between enforcement agencies and community stakeholders to enforce underage drinking laws and educate the public.

This plenary will be of interest to alcohol law enforcement officers and community activists alike, as particular attention will be paid to the ways in which ABC agencies can work collaboratively with local law enforcement agencies, and with the community to prevent underage drinking and alcohol-related harm.





He also was a facilitator at the MADD National Youth Summit in Washington, DC, and has been a Youth in Action since 2000.

#### **JAN BYRNE**

Jan Byrne is the Education Coordinator for the Alabama Alcoholic Beverage Control Board. She also coordinates the Alabama Responsible Vendor Program, which trains people who sell alcohol and tobacco. Cantelon is a Social Science Program Specialist at the Office of Juvenile Justice and Delinguency Prevention (OJJDP), U.S. Department of Justice, Ms. Cantelon works extensively with Federal and State agencies to coordinate efforts to support youth-related programs. Since 1998, she has worked with OJJDP's Enforcing the Underage Drinking Laws Program (EUDL), monitoring discretionary grants to States. She also assists with the planning and coordination of media events to generate community support for changes in social norms. Ms. Valenciano has a master's degree in Cultural Anthropology from University of California, San Diego. Her previous work includes teaching ESL and coordinating a resettlement program for African, European, and Afghan refugees.

#### **JAMES E. VAN DOREN**

Sergeant James E. Van Doren is a Shift Supervisor for the George Mason University Police Department. He also has been a patrol officer, a field training officer, and a defensive tactics instructor. During his 8 years in the Army, Sergeant Van Doren served as a Patrol Officer and Traffic Accident Investigator. He completed instructor development courses sponsored by the U.S. Military and the Virginia Department of Alcohol Beverage Control. Over the past 4 years, Sergeant Van Doren has received grants from the Virginia Department of Alcohol Beverage Control to assist the George Mason University Police Department in their efforts to enforce alcohol laws.

He instructs prosecutors and law enforcement officers in Michigan on a variety of traffic safety topics and other similar issues. Mr. Wallace is a former Calhoun County Assistant Prosecutor with more than 15 years of active trial experience.

#### **JUDY WALSH-JACKSON**

Judy Walsh-Jackson is the Co-Chair of the Collegiate Alcohol Research and Prevention Initiative (CARPI), Chair of the San Diego County Council on Alcohol Policy, and a member of the Board of Directors for the California Council on Alcohol Policy and of the National Council on Alcoholism and Drug Dependence (NCADD)-San Diego. Ellen Ward leads the Robert Wood Johnson Foundation Reducing Underage Drinking through Coalitions in Texas. Broad-based community prevention has been the focus of her career. She serves on numerous committees, as well as the Institute for Public Strategies Advisory Board, and is a member of the American Public Health Association.

#### **KEN WARNBERG**

Ken Warnberg is a Sergeant with the Minneapolis Police Department, where he coordinates liquor enforcement and reviews all liquor applications received by the city. He has worked on combating underage drinking in the University of Minnesota area by joining with the University of Minnesota Police and the State Patrol in raiding large party houses in the university area. From this work, numerous adult providers have been charged with purchasing/providing alcohol to minors, hundreds of minors have been cited, and some peace has been restored to the affected neighborhoods.

#### **CATHY WENDHOLD-MCDADE**

Cathy Wendhold-McDade is the District Tobacco Use Prevention Director for the Cobb and Douglas Boards of Health in Georgia. She is responsible for educating community members and healthcare providers about the harmful effects of tobacco use. Ms. Wendhold-McDade also is responsible for coordinating local tobacco coalitions that concentrate on enacting policy change to effect tobacco use and exposure. As a member of the Cobb Underage Drinking Task Force, a number of collaborative efforts have taken place that benefit both youth access to and use of tobacco and alcohol.
