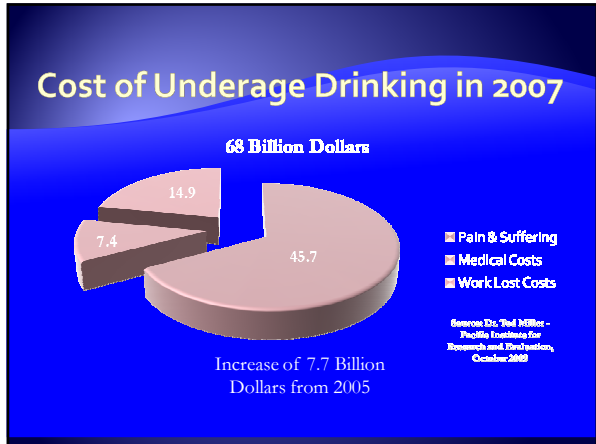

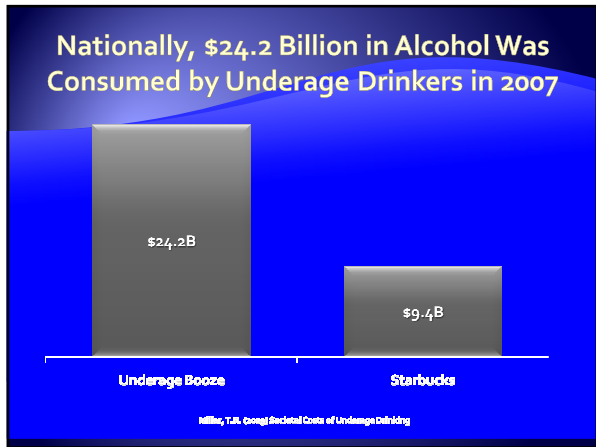

A Devastating Tidal Wave of Alcohol-Related Harm Has Resulted

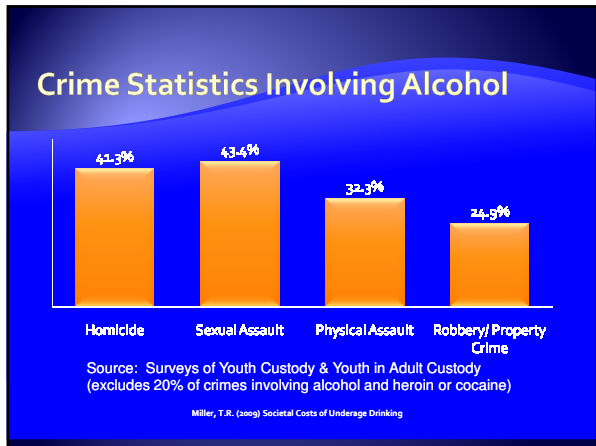
- 3170 deaths


