Two Mundelein High School Students Lead Social Host Development across Lake County, Illinois

Lake County, in the far northeastern corner of Illinois, has a population of 713,076 (2006). In 2007, the Lake County After-School Coalition and the Lake County Chiefs of Police Association jointly established the Lake County Underage Drinking Prevention Task Force (LCUDPTF). The goals of the Task Force are to have consistent and enforced social host ordinances in all Lake County municipalities to decrease youth access to alcohol and to reduce acceptance of underage drinking by increasing awareness of the associated risks and consequences related to youth alcohol use. Youth leadership and involvement played a critical role in advancing the efforts of the Task Forces' hard work. This Success Story shares the considerable effectiveness of partnering with youth and the significant results for Lake County.

American Academy of Pediatrics Recommends Youth be Screened for Alcohol Use

Recently, the American Academy of Pediatrics Committee on Substance Abuse revised a policy noting the issue is a "pediatric concern." The committee noted that the latest neurological research indicates the harmful effects from alcohol to adolescent brain development; this evidence of the harmful effects of alcohol provides even more evidence to support the call to prevent and reduce underage drinking. Texas Alcoholic Beverage Commission Partners with the Information Resource Division to Develop Effective Community Tool

The Texas Alcoholic Beverage Commission (TABC) has always supported communities by assisting them with tracking retailer compliance. However, the process was often time consuming. TABC collaborated with the Texas Information Resource Division (IRD) resulting in the development of a public inquiry system that is available on the TABC Web site. Now anyone can access the public inquiry system 24 hours a day, 7 days a week to receive immediate information regarding TABC-issued licenses and permits. This Success Story shares how the importance of this collaborative relationship resulted in an effective information technology resource, allowing the TABC to be more transparent in enforcement while providing exemplary customer service to communities working to prevent underage drinking.

Two Mundelein High School Students Lead Social Host Ordinance Development across Lake County, Illinois

Lake County, in the far northeastern corner of Illinois, has a population of 713,076 as of 2006. In 2007, the Lake County After-School Coalition and the Lake County Chiefs of Police Association jointly established the Lake County Underage Drinking Prevention Task Force (LCUDPTF). The goals of the Task Force are to have consistent and enforced social host ordinances in all Lake County municipalities to decrease youth access to alcohol and to reduce countywide and community-level acceptance of underage drinking by increasing awareness of associated risks and consequences and by educating the community on the norms related to youth alcohol use.

Youth leadership and involvement have been crucial in advancing the efforts of the Task Force's efforts. Two talented and committed Mundelein High School students, Kushali Rami and Kaitlyn Ellett, were also critical in advancing prevention efforts. Their chosen project was the advancement of social host ordinance development or updates in all municipalities throughout the county. Both students were significant to the leadership team, not only by providing the insight necessary to understand the "underage perspective," but also by developing a youth presentation to bring a social host ordinance to their village board and to train students from other communities to do the same with their LCUDPTF for dissemination.

The youth continually availed themselves as resources to elected officials and police chiefs. They helped to develop strategies to overcome barriers to the passing of social host ordinances across the county, including the development of a script for use in municipality presentations that outlined local data; the importance of working together to keep youth alive, safe, and healthy; and emphasized the position, "Why would you not pass an ordinance to protect youth after hearing all of this information?" They also participated in a live cable TV panel on underage drinking prevention!

In only one year, 19 Lake County municipalities have either developed and passed a new social host ordinance or amended ordinances to be as inclusive as the model social host ordinance. Four additional municipalities along with the county are currently in the process of adopting the ordinance.

The LCUDPTF is now working towards monitoring the enforcement of the new ordinance in those municipalities that have adopted it and promoting it in the communities that have not yet considered it.

Texas Alcoholic Beverage Commission (TABC)'s Information Resource Division develops effective community tool

The Texas Alcoholic Beverage Commission (TABC) strongly supports communities by assisting them with tracking retailer compliance. The process of requesting assistance, however, is not directly to the TABC, but through an open records process that takes up to 10 days for a response. In 2006, in an effort to be more transparent to communities, the TABC's Information Resource Division (IRD) developed a public inquiry system that is available on the TABC Web site. Now, using the public inquiry system, anyone can immediately access information regarding TABC-issued licenses and permits 24 hours a day, 7 days a week. To date the inquiry system has been successful, both operationally and perceptually. Access to this data is critical to communities in identifying effective strategies to prevent youth's access to alcohol. "Texas is a recognized leader for open government and public access to information," said Jay Webster, the IRD Director. "Public inquiry provides our citizens with anytime, anywhere information in formats that support their efforts to prevent underage drinking."

Preventing underage drinking is a challenge, but evidence has shown that if communities collaborate, success is possible. An overlooked partner in preventing youth access is often the licensed alcohol retailers. Many retailers are supportive in preventing youth access to alcohol by checking identifications and refusing to sell to minors. Though appreciating retailers' support of underage drinking efforts, it is just as important to be cognizant of retailers that need additional support. In a State that is 268,820 square miles with more than 40,000 licensed retailers, communities can find it difficult to know the number of alcohol retailers in their areas, much less the violation or complaint history of these establishments. The public inquiry system resulting from the partnership between TABC and IRD uses a variety of methods to support users with their efforts to prevent underage drinking:

- Users can look up an existing license/permit number and verify the status of the retailer's license/permit.
- Users can check the status of a pending license/permit.

- Users can create a list of licenses or permits in a specific geographic area based on four pieces of information:
 - Location including the city, county, and/or ZIP code
 - Type of license/permit including retailers, wholesalers, manufacturers, or other types
 - Status of license/permit including active, inactive, and/or pending applications
 - Original issue date (optional)
- Users can also research public complaints issued against licenses or permits (i.e., sales to minors, administrative allegations). If a violation is found, the user may access a complaint summary of the findings.

The importance of this information technology (IT) resource in assisting communities has been invaluable to the State. This Success Story shares how the importance of this collaborative relationship resulted in an effective IT resource that allows the TABC to be more transparent in enforcement while providing exemplary customer service to communities working to prevent underage drinking.


